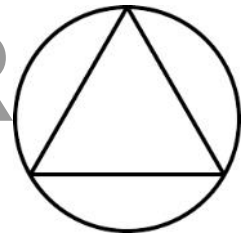

## Intergroup Committee Elections

**Nominations: November 12th at 12:30pm**

**Elections: December 10th at 12:30pm**

**Chairperson:** Chairs all meetings and is authorized to sign any banking transactions. When needed, appoints ad hoc committees and tallies votes.

**Vice-Chairperson:** In the absence of Chairperson, the Vice-Chairperson acts as Chairperson for the monthly meetings of Intergroup Representatives.

**Secretary:** Records minutes of Intergroup meetings and sends them in a timely fashion to the Chairperson, Office Manager and Newsletter.

**Treasurer:** Reviews ETIAA accounting books. Ensures current financial statements and reports are available at monthly Intergroup meetings. Reviews all expenses over \$100 except previously approved or standard expenses. Signs checks as needed, usually every other week.

**Accessibilities Committee:** This group provides aid to AA members needing assistance due to various disabilities.

**Spanish Speaking Liaison:** Visits Latin groups and is available for phone calls from Spanish-speaking AA members.

**Treatment Committee:** Formed to coordinate the work of individual members and groups interested in carrying AA's message of recovery to alcoholics in treatment and outpatient settings.

**Hotline Coordinator:** Manages coverage and training for all volunteer hotline service workers.

**Website Liaison:** Manages the Intergroup website.

**CPC/PI (Cooperation with the Professional Community and Public Information Committees):**

Through PI service, accurate information about AA, when requested, is presented to the public. PI volunteers visit schools, businesses and commu-

nity meetings; they serve as resources for AA friends in the local media, emphasizing AA traditions of anonymity, singlelness of purpose and non-affiliation; they provide AA public service announcements to radio and TV outlets.

**Cooperation with the Professional Community:** CPC provides information about AA to those who have contact with alcoholics through their professions: healthcare professionals, educators, members of the clergy, lawyers, social workers, union leaders and industrial managers, as well as those working in the field of alcoholism. CPC advises what AA is, how AA can be contacted, where AA is located, and what AA can and cannot do.

**Archives Committee:** Members maintain and update Intergroup Archives, the repository of personal collections, manuscripts, publications, photographs and memorabilia related to the origin and development of the regional AA Fellowship.

**Corrections Committee:** This group is aware of all regional prison/jail commitments and provides information and literature about AA to others going into all such area facilities.

**Outreach Committee:** Members visit regional AA meetings to talk about Intergroup's mission and, when needed, to recruit volunteers.

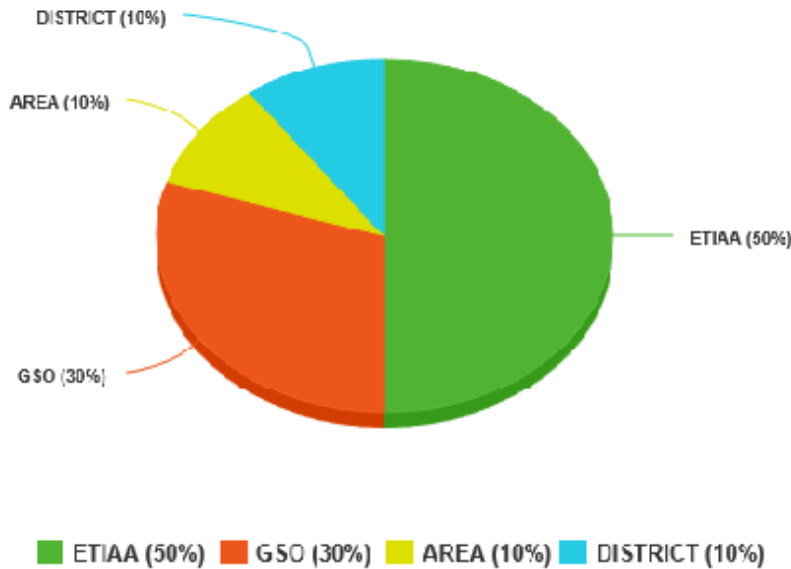

DCM 51 Report: (Trey M.) Post conference report attended on Saturday. Prime time still having trouble with flooding of treatment facilities.

DCM 50 Report: (Caitlin F.) Attended several groups. Phoenix group is now an official group- sent in new group and new GSR forms. Went to post conference report on Saturday. This is what I learned: 1.) Less groups are contributing money but the ones that are contributing are contributing more money. 2.) Profit was 1.5 million- most of which was invested in retirement funds to meet legal requirements. 3.) \$7.27 per member annually would cover most costs for each member. 4.) There are 41.5% of groups sending money to GSO. 5.) \$1 in 1939 = \$17 today. 6.) We need to decrease costs to increase productivity and save money. 7.) Online contributions are most cost effective over mailed envelopes or check donations (saves a lot a money). 8.) Any groups that can do online donations should. 9.) Grapevine subscriptions have decrease but cost has increased. 10.) PI/Grapevine approved to create YouTube and Google for NP with disabled comments. 11.) 2017 Survey is on hold until issue of gender question is resolved.
