# Humbly asked Him to remove our shortcomings.

#### Seventh Step Prayer

"My Creator, I am now willing that you should have all of me, good and bad. I pray that you now remove from me every single defect of character which stands in the way of my usefulness to you and my fellows.

#### Step Seven — Understanding and Learning Humility

Dictionary.com lists several variances on the definition of the word humble. To get a good grasp on the concept of humility, try picturing circumstances in your life (real or imagined) where humility comes into play and determine how those emotions can influence your interaction with God as you understand Him while working through Step 7.

One definition is to be "not proud or arrogant; modest." This example of humility is a lesson learned early in life. Imagine yourself as a kindergartner who just created the most beautiful picture of a bunny any kindergartner had ever seen. (At least that's how you felt when your teacher complimented your drawing and held it up in front of the class.) Immediately, you were filled with the natural response of pride.

At that point, you would have transitioned from natural pride to either modest pride or arrogant pride. The choice was yours whether you were conscious of it or not. Modest pride would have filled you with the good feeling of accomplishing something special; arrogant pride would have filled you with that same feeling with the added sense of feeling superior to your kindergarten peers. So, to be truly humble, you would have stopped at the natural pride before allowing it to make you feel superior. Therein lies the difference between arrogance and humility.

#### **Modest Humility Necessary**

Modest humility is necessary in accomplishing Alcoholics Anonymous Step 7. In order to benefit from this step, you will need to approach God as you

#### Step Seven: Humbly asked Him to remove our shortcomings.

**SINCE** this Step so specifically concerns itself with humility, we should pause here to consider what humility is and what the practice of it can mean to us.

Indeed, the attainment of greater humility is the foundation principle of each of A.A.'s Twelve Steps. For without some degree of humility, no alcoholic can stay sober at all. Nearly all A.A.'s have found, too, that unless they develop much more of this precious quality than may be required just for sobriety, they still haven't much chance of becoming truly happy. Without it, they cannot live to much useful purpose, or, in adversity, be able to summon the faith that can meet any emergency.

Humility, as a word and as an ideal, has a very bad time of it in our world. Not only is the idea misunder-stood; the word itself is often intensely disliked. Many people haven't even a nodding acquaintance with humility as a way of life. Much of the everyday talk we hear, and a great deal of what we read, highlights man's pride in his own achievements.

#### **Seventh Step Prayer**

My Creator, I am now willing that You have all of me, good and bad. I pray that You now remove from me every single defect of character which stands in the way of my usefulness to You and my fellows. Grant me strength, as I go out from here to do Your bidding.

**Tradition Seven (long form):** Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A. such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A. —and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never to go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.

#### **Tradition Seven Checklist:**

- 1. Honestly now, do I do all I can to help AA (my group, my central office, my GSO) remain self-supporting? Could I put a little more into the basket on behalf of the new guy who can't afford it yet? How generous was I when tanked in a barroom?
- 2. Is a group treasurer's report unimportant AA business? How does the treasurer feel about it?
- 3. How important in my recovery is the feeling of self-respect, rather than the feeling of being always under obligation for charity received?

#### **Concept VII Checklist:**

The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon tradition and the A.A. purse for final effectiveness.

- Do we act responsibly regarding the "power of the purse"?
- Do we realize that the practical and spiritual power of the Conference will nearly always be superior to the legal power of the G.S.B.?


# How can groups participate?

To help support AA's essential services, the General Service Conference suggests that individual groups, through an informed group conscience, adopt a specific contribution plan tailored to meet the group's financial situation. Once the basic group expenses have been taken care of (for example, rent, refreshments, AA literature, Grapevine literature, local meeting lists, GSR travel expenses to attend service functions) and a "prudent reserve" has been set aside to cover any emergency contingencies that might arise, the group may decide to further carry the message by sending money to the following AA service entities.

- The local district, which communicates directly with the groups, providing the district group conscience for the area assemblies and serving as a link between the area delegates and the GSRs.
- The area committee, which coordinates vital AA activities over a broad geographic area, sends a delegate to the annual General Service Conference, holds area assemblies to determine the needs of the Fellowship, and provides information at all levels of service.
- The local intergroup or central office, which may provide phone service for Twelfth Step calls and other inquiries, coordination of group activities, AA literature sales, institutions work, public information, and cooperation with the professional community activities.
- AA's General Service Office, which functions as a storehouse of AA information, communicating with members and groups around the world, publishes AA literature, and supplies information and experience to professionals and others interested in AA.


#### Notes to our members:

# Mobile Intergroup — An Outreach Tool

On a cool Tennessee afternoon in February 2020 (when A.A.s gathered in person — before Coronavirus closures), Rebekah R., office manager of the East Tennessee Intergroup of Alcoholics Anonymous (ETIAA), along with a few A.A. volunteers, showed up a few hours before a scheduled event, unloaded and unpacked boxes of items, and began setting up displays. In the weeks prior to the event, flyers were passed out advertising a "Mobile Intergroup Workshop." Now, thanks to the flyers and word of mouth, curious and interested A.A.s were gathered in front of the table. While a volunteer filmed the entire workshop (without showing faces, of course), Rebekah took her place behind the displays of books, pamphlets, information boards and other assorted items. She greeted the crowd and began to speak about how to bring intergroup — and, more importantly, why to bring intergroup — to your event.

She shared a condensed overview of an intergroup: "The purpose of an intergroup is to facilitate Twelfth Step work. That is our main purpose. It is why we have a hotline — to get people together to do Twelfth Step calls." Briefly, she described the difference between an intergroup and the General Service Office: "We [intergroup] do the things individual groups can't do, like set up a hotline number, carry lots of literature, and keep our meeting information up to date in the Meeting Guide app. We make it easier for A.A.s in our area to carry out Twelfth Step work." While G.S.O. also makes Twelfth Step work possible, she pointed out, "They do things an intergroup can't, like publishing books and running the General Service Conference."

The purpose of the Mobile Intergroup Workshop was not only to communicate the functions of an intergroup, but also to show area A.A.s that they, too, could join their intergroup and extend its reach by bringing it to their area events — literally. Gesturing to the tables laden with information, books and other items, Rebekah said, "Although it may look like our mobile intergroup is just selling things, our main focus is to be of service, especially to areas that cannot get to us easily." The ETIAA provides coverage for seven districts within Area 64 (Tennessee), which includes 25 counties with approximately 120-150 groups and 400-500 meetings per week.

While a still-suffering alcoholic may first hear A.A.'s message from any one of a number of sources, for many A.A. members, it was someone at a local intergroup or central office who answered their first shaky call asking for help and who communicated A.A.'s message of hope and recovery. Intergroup was the "hand of A.A." that was ready and waiting to be extended when that drunk gathered up the courage to call. The mobile intergroup, according to Rebekah, improves communication because it is an "outreach tool for intergroup. Using it, we can tell people about intergroup so that they can use us. If they don't know we're here, they can't use us."

As Bill W. said in an address to the 1960 General Service Conference, "When you think about it, A.A. is a unique means of communication: our lives have depended on communication; our unity depends on communication; our function depends on communication.

Everything has hung on this business of communication." (Our Great Responsibility, pp. 101–102).

Using ability and imagination, A.A.s have communicated the message of hope and recovery in a multitude of ways — and through a multitude of outlets.

In this spirit, ETIAA has posted the workshop on YouTube so anyone interested in using mobile intergroups to help carry the A.A. message can learn more.



#### Like a Frog in a Frying Pan ::: From The AA Grapevine -- January 1978

A psychological experiment of relevance to those of us who wait until things get too hot

I DID NOT come to AA to learn about a Higher Power. I did not even come to AA to stay sober. I came to AA to save my life. After I got to AA, I accepted what you people were telling me: that the way for an alcoholic to stay alive is not to take a drink a day at a time. And then I knew that if I was not to drink, I would need help. I am powerless over alcohol.

When I had been sober about a year, I was talking about alcoholism one evening with my older daughter. I told her that I had been unable to stop drinking. She replied, "But you did stop!" I was at a loss to explain myself until I remembered the story of the frog in the frying pan. It is a classic story of a psychological experiment that has a lot of meaning for me.

In the experiment, a healthy frog is placed in a shallow frying pan filled with water, and the frying pan is put on the stove. The heat under the frying pan is turned on and gradually increased--so gradually that the frog can't tell the difference from one moment to the next. The frog is completely unencumbered and is free to jump out at any time he chooses. He does not. He is boiled to death. One can almost imagine that even the frog realizes at the last moment--panic-stricken and in terror, as his neurons finally scream to awaken his instinct to escape--that he has waited too long. It is too late.

The psychological point of the experiment is to demonstrate the concept of the Just Noticeable Difference, or JND, which is the threshold below which an organism cannot make sensory discriminations, though the sensations reaching it may be unpleasant or even signs of danger. I used the story in my conversation with my daughter as an analogy to the situation of the alcoholic--at least, of this alcoholic. I drew three conclusions.

First, the behavior of the alcoholic is insane, as is that of the frog, even on the instinctual level of self-preservation. I have attended meetings at which the Second Step is debated and criticized and alcoholic behavior is defended as, well, perhaps not prudent, but certainly not insane. Using hot water isn't insane, either, unless you're being boiled to death in it.

My second conclusion is that there is nothing persuasive to me in the argument that an alcoholic is genetically predisposed to his condition. How did the frog get in the frying pan? He found himself there. If anything, I think an alcoholic has to be a superior specimen, at least physically. It takes the constitution of a horse for the body to withstand the extreme physical abuse we heap upon ourselves for years. Of course, many don't make it. Those of us in AA are indeed survivors.

Third, I had to have help to get out of my own frying pan of boiling water that is alcoholism. I could not do it on my own, and did not. It took a miracle. The story of how I was taken out is not mysterious; it is ordinary. So is the story of how I stay sober a day at a time in AA. That does not make it any less miraculous. You see, it happened to me. For every person reading this article, there are a dozen, perhaps two dozen, to whom that miracle did not happen, or who rejected it. Can you imagine how a conversation with the frog might go when things are beginning to get warm?

AA: "Hey there. It looks to me like you're getting in trouble with your life."

Frog: "I'm okay. I'm better off than a lot of those frogs who get caught in traps or stuck with needles or cut up for study. Things are getting hot, but I can handle it."

AA: "You don't have to wait until things get worse, you know. That water is going to keep getting hotter. There is a way out."

Frog: "Don't bug me. I'm not like the rest of those frogs who got in trouble. I'm different--really a little superior to the likes of you. When I need your help, I'll let you know. Now buzz off."

I fought as long as I could to keep drinking. I was one hundred percent convinced that I could not live without alcohol. I had reached the place of the alcoholic Bill W. describes on page 152 of the Big Book: ". . .unable to imagine a life either with alcohol or without it. Then he will know loneliness such as few do. He will be at the jumping-off place. He will wish for the end."

I was nearing that point when I was taken out of the frying pan by friends, AA, love, and a Higher Power. I believe I would now have six months to live--if the clock was running. The thing that would start it running is my taking a drink--which I might do if I ever think I can take over full control of my own life.

Superior people, just as we can imagine superior frogs, like to think they're in control. They analyze, intellectualize, and demand proof. If they aren't naturally skeptical, they are taught to be. I had my skepticism nurtured and refined through twenty years of the finest education, enough for a Ph.D. at an illustrious private midwestern university. But if I'm so smart, I ought to learn from minds greater than my own.

Prove God? No way, in the accepted scientific method of classical physics. Indeed, Soren Kierkegaard, the Danish philosopher who founded existentialism, thought he had proved that there is no proof of God (a very philosophical thing to do). His immortal legacy is the statement that "faith is a leap into the unknown."

William James, whose book *The Varieties of Religious Experience* is cited by Bill W. on page 28 of the Big Book, wrote in 1901 that "God is real since His effects are real." James was not only a distinguished psychologist but also a founder of the philosophical school of pragmatism. The proposition of this school is that no belief can be considered true unless it makes a difference in real life.

When I first took the Third Step, I waited for proof--some sign--that God had received my will and my life. And I waited and I waited. Then it occurred to me that the Third Step is not a prescription for God's behavior. As far as I can tell, God is doing quite well. The sun rises in the morning; the seasons change; and there is love in the world. The purpose of the Third Step is to tell me what to do. How defiantly contemptuous of me to demand proof of the existence of God. I'm the one in trouble!

I think it is not coincidence that many people see in God the force of love. The two are equally improbable and unprovable. To those demanding their own form of proof of God, I suggest that they demand also proof of beauty, of truth, of love. "What?" they say. "But truth and beauty and love are all around us. They do not need to be proved." And so with God. "God is real since His effects are real."

The razor-keen mind will rejoin that the occurrence of tragedy and accidents disproves God. To be sure, malice, greed, and misfortune do exist in the world--you and I have experienced them. But disprove God? Disprove love? Read William James. The improbable, unprovable miracle is still there. I can even conceive of an imperfect God, striving for perfection.

I cannot close without reference to the towering intellectual giant of our century, and very likely the most spiritual, Albert Einstein. In that dazzling survey of human accomplishment, The Ascent of Man, of Man, Jacob Bronowski writes that Einstein was fond of talking about God. He quotes Einstein as saying, "God does not play at dice. God is not malicious." Bronowski goes on to say, "Einstein was a man who could ask immensely simple questions. And what his life showed, and his work, is that when the answers are simple, too, then you hear God thinking." AA is to me the sound of God thinking.

Thank you for my life.

know Him with an attitude of accomplishing something special with modesty instead of arrogance.

Any sense of arrogance about your shortcomings defeats the purpose of asking God to remove them because to ask Him to help you is to need Him, and to need Him is to be modest in front of Him.

Another definition of the word humble is "having a feeling of insignificance, inferiority, subservience, etc." This is another example of one of life's early lessons. When you were a toddler, your parents, older relatives, babysitters or daycare teachers would likely have impressed upon you with words or actions that your position in relation to them was inferior or subservient. Your job was to listen to and obey those who were older, wiser and more experienced than you. Your position of inferiority or subservience wasn't a character flaw by any means; it was simply indicative of your place in society.

Understanding and placing yourself in this position of inferiority and subservience is necessary when approaching God as you understand Him while you ask Him to remove your shortcomings. To allow yourself to feel somehow equal to Him would defeat the purpose of asking Him to remove anything from your life. If you understand that you need Him to remove your shortcomings, you understand that He is more powerful and superior than you.

A position of humility without arrogance and a position of inferiority toward God as you understand Him will allow you to experience His power in removing your shortcomings. This humility is a necessary experience in succeeding at Step 7.
