A.A. Oldtimers...On the Ninth Step A.A. Grapevine, July 1945, Vol. 2 No. 2

"Made direct amends to such people wherever possible except when to do so would injure them or others."

Like others of the Steps, Number Nine is closely related to Number Three –"to turn our will and our lives over to God as we understood Him." If we have accomplished this step to any measurable degree, we have attained at least a small measure of humility and a realization of our dependence on Him.

Having prepared a list of all people we have harmed and brought ourselves to the point where we are willing to make amends to them, our Ninth Step is one calling for positive action. There is a world of difference between being willing to do a thing and actually doing it. How many times in the pre-A.A. state have we said "I am sorry, I won't do it again" and felt that that constituted complete amends.

A sincere apology, with a true explanation to the person harmed, of what we believe to be the reason for our past actions can quite frequently readjust personal relations –but the A.A. realizes that this cannot take care of the ones we have really hurt and invariably these are the ones we should and do love most.

Most of us had at least a few years of real pathological drinking behind us when we first learned of the Twelve Steps. Those terrible years are the ones that become repulsive to us as we progress in our new-found life program for order and happiness—years in which our every action was influenced by alcoholic thinking, with all its implications. It naturally follows that whatever our state in life may be, those close to us bore the brunt of our outrageous behaviour. How can one make amends to a dear wife, son or daughter or parent who through no fault of their own truly suffered physically and financially and more important, mentally, the humiliation and embarrassment of going through life with a drunkard? A simple "I am sorry; it won't happen again" is not enough. It is not enough for us and it is not enough for the agrieved person.

Direct amends, by all means, is a must, in restoring physical property to the rightful owner, paying debts willingly within our ability to do so and retracting the lie that hurt a reputation; but the real amends are made in scrutinizing our day-in and day-out conduct and keeping that conduct "on the beam." The loved ones whom we have hurt don't want their "pound of flesh." Whether they are still in daily contact with us or not, amends are best made to them by restoring the love and confidence and respect they once had for us by the action of right living. With that thought clearly in our minds that "first drink" is an improbability, even an impossibility and the well-rounded, good life we all yearn for becomes readily visible to us.

Step Nine: "Made direct amends to such people wherever possible except when to do so would injure them or others."

GOOD judgment, a careful sense of timing, courage, and prudence—these are the qualities we shall need when we take Step Nine.

After we have made the list of people we have harmed, have reflected carefully upon each instance, and have tried to possess ourselves of the right attitude in which to proceed, we will see that the making of direct amends divides those we should approach into several classes. There will be those who ought to be dealt with just as soon as we become reasonably confident that we can maintain our sobriety. There will be those to whom we can make only partial restitution, lest complete disclosures do them or others more harm than good. There will be other cases where action ought to be deferred, and still others in which by the very nature of the situation we shall never be able to make direct personal contact at all.

Ninth Step Prayer

Higher Power, I pray for the right attitude to make my amends, being ever mindful not to harm others in the process. I ask for Your guidance in making indirect amends by staying abstinent, helping others and growing in spiritual progress.

Tradition Nine (long form):

Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office in New York. They are authorized by the groups to handle our overall public relations, and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.

Tradition Nine Checklist:

- 1. Do I still try to boss things in AA?
- 2. Do I resist formal aspects of AA because I fear them as authoritative?
- 3. Am I mature enough to understand and use all elements of the AA program—even if no one makes me do so—with a sense of personal responsibility?
- 4. Do I exercise patience and humility in any AA job I take?
- 5. Am I aware of all those to whom I am responsible in any AA job?
- 6. Why doesn't every AA group need a constitution and bylaws?
- 7. Have I learned to step out of an AA job gracefully—and profit thereby—when the time comes?
- 8. What has rotation to do with anonymity? With humility?



Concept IX and Checklist: Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.

- Do we discuss how we can best strengthen the composition and leadership of our future trusted servants?
- Do we recognize the need for group officers? What is our criteria for election? Do we sometimes give a position to someone "because it would be good for them"?
- Do I set a positive leadership example?

7TH TRADITION SUGGESTED CONTRIBUTIONS

How can groups participate?

To help support AA's essential services, the General Service Conference suggests that individual groups, through an informed group conscience, adopt a specific contribution plan tailored to meet the group's financial situation. Once the basic group expenses have been taken care of (for example, rent, refreshments, AA literature, Grapevine literature, local meeting lists, GSR travel expenses to attend service functions) and a "prudent reserve" has been set aside to cover any emergency contingencies that might arise, the group may decide to further carry the message by sending money to the following AA service entities.


• The local district, which communicates directly with the groups, providing the district group conscience for the area assemblies and serving as a link between the area delegates and the GSRs.

• The area committee, which coordinates vital AA activities over a broad geographic area, sends a delegate to the annual General Service Conference, holds area assemblies to determine the needs of the Fellow-ship, and provides information at all levels of service.

• The local intergroup or central office, which may provide phone service for Twelfth Step calls and other inquiries, coordination of group activities, AA literature sales, institutions work, public information, and cooperation with the professional community activities.

• AA's General Service Office, which functions as a storehouse of AA information, communicating with members and groups around the world, publishes AA literature, and supplies information and experience to professionals and others interested in AA.



I know who you are. You are "X" who attends the "ABC Meeting" at the "XYZ Club" where AAs meet in Anywhere, U.S.A.

I saw you there the other night at the eight o'clock meeting. I don't know how long you've been sober, but I know you've been coming around for a while because you spoke to a lot of people who knew you.

I wasn't one of them.

You don't know who I am. I wandered into your meeting place alone the other night, a stranger in a strange town. I got a cup of coffee, paid for it, and sat down by myself.

You didn't speak to me.

Oh, you saw me. You glanced my way, but you didn't recognize me, so you quickly averted your eyes and sought out a familiar face.

I sat there through the meeting.

It was okay–a slightly different format but basically the same kind of meeting as I attend at home.

The topic was gratitude. You and your friends spoke about how much AA means to you. You talked about the camaraderie in your meeting place. You said how much the people there had helped you when you first came through the doors—how they extended the hand of friendship to make you feel welcome, and asked you to come back.

And I wondered where they had gone, those nice people who made your entrance so easy and so comfortable.

You talked about how the newcomer is the life's blood of AA. I agree, but I didn't say so. In fact, I didn't share in your meeting. I signed my name in the book that was passed around, but the chairperson didn't refer to it. He only called on those people in the room whom he knew.

So who am I? You don't know, because you didn't bother to find out. Although yours was a closed meeting, you didn't even ask if I belonged there.

It might have been my first meeting. I could have been full of fear and distrust, knowing AA wouldn't work any better than anything else I'd tried, and I would have left convinced that I was right.

I might have been suicidal, grasping at one last straw, hoping someone would reach out and pull me from the pit of loathing and self-pity from which, by myself, I could find no escape.

I might have been a student with a tape recorder in my pocket, assigned to write a paper on how AA works–someone who shouldn't have been permitted to sit there at all but could have been directed to an open meeting to learn what I needed to know.

Or I could have been sent by the courts, wanting to know more, but afraid to ask.

It happens that I was none of the above.

I'm just an ordinary drunk with a few years of sober living in AA who was traveling and was in need of a meeting.

My only problem that night was that I'd been alone with my own mind too long. I just needed to touch base with my AA family.

I know from past experience that I could have walked into your meeting place smiling, stuck out my hand to the first person I saw and said, "Hi. My name is —-. I'm an alcoholic from —-."

If I had felt like doing that, I probably would have been warmly welcomed. You would have asked me if I knew "Old So-and-so" from my state, or you might have shared a part of your drunkalog that occurred in my part of the country.

Why didn't I? HALT. I was hungry, lonely, and tired. (The only thing missing was angry, and three out of four isn't a good place for me to be.)

So I sat silently through your meeting, and when it was over I watched enviously as all of you gathered in small groups, talking to one another the same way we do in my home town.

You and some of your friends were planning a meeting after the meeting at a nearby coffee shop. By this time I had been silent too long to reach out to you. I stopped by the bulletin board to read the notices there, kind of hanging around without being too obvious, hoping you might ask if I wanted to join you, but you didn't.

As I walked slowly across the parking lot to my car with the out-of-state license plates you looked my way again. Our eyes met briefly and I mustered a smile. Again, you looked away.

I buckled my seat belt, started the car, and drove to the motel where I was staying.

As I lay in my bed waiting for sleep to come I made a gratitude list. You were on it, along with your friends at the meeting place. I knew that you were there for me, and that I needed you far more than you needed me. I knew that if I had needed help, and had asked for it, you would have gladly given it. But I wondered. . .what if I hadn't been able to ask?

I know who you are.

Do you remember *me*?

Sixteen relapse symptoms to watch out for:

1. Exhaustion - Allowing oneself to become overly tired; usually associated with work addiction as an excuse for not facing personal frustrations.

2. Dishonesty - Begins with pattern of little lies; escalated to self-delusion and making excuses for not doing what's called for.

3. Impatience - I want what I want NOW. Others aren't doing what I think they should or living the way I know is right.

4. Argumentative - No point is too small or insignificant not to be debated to the point of anger and submission.

5. Depression - All unreasonable, unaccountable despair should be exposed and discussed, not repressed: what is the "exact nature" of those feelings?

6. Frustration - Controlled anger/resentment when things don't go according to our plans. Lack of acceptance. See #3.

7. Self-pity - Feeling victimized, put-upon, used, unappreciated: convinced we are being singled out for bad luck.

8. Cockiness - Got it made. Know all there is to know. Can go anywhere, including frequent visits just to hangout at bars, boozy parties.

9. Complacency - Like #8, no longer sees value of daily program, meetings, contact with other alcoholics, (especially sponsor!), feels healthy, on top of the world, things are going well. Heck may even be cured!

10. Expecting too much of others - Why can't they read my mind? I've changed, what's holding them up? If they just do what I know is best for them? Leads to feeling misunderstood, unappreciated. See #6.

11. Letting up on disciplines - Allowing established habits of recovery - meditations, prayer, spiritual reading, AA contact, daily inventory, meetings - - to slip out of our routines; allowing recovery to get boring and no longer stimulating for growth. Why bother?!

12. Using mood-altering chemicals - May have a valid medical reason, but misused to help avoid the real problems of impending alcoholic relapse.

13. Wanting too much - Setting unrealistic goals: not providing for short-term successes; placing too much value on material success, not enough on value of spiritual growth.

14. Forgetting gratitude - Because of several listed above, may lose sight of the abundant blessings in our everyday lives: too focused on # 13.

15. "It can't happen to me." - Feeling immune; forgetting what we know about the disease of alcoholism and its progressive nature.

16. Omnipotence - A combination of several attitudes listed above; leads to ignoring danger signs, disregarding warnings and advice from fellow members.
